## CHILD ABUSE/MANDATED REPORTER TRAIRDAGE

Chapter 56 of the Laws of 2021 amended Social Services Law § 413 to require additional training in protocols to reduce implicit bias in decisionaking processes, strategies for identifying adverse childhood experiences, and guidelines to assist in recognizing signs of abuse or maltreatment while interacting virtually within the New York State Mandated Identification and Reporting of Child Abus Mattreatment/Neglect coursework.
